### 10. EXECUTIVE SESSION

Upon a public majority vote of the members constituting a quorum, the Council may hold an Executive Session that is not open to the public for the following purposes:

- a. To consult with legal counsel for advice on matters listed on this agenda per A.R.S. §38-431.03(A)(3)
- b. Per ARS 38-431.03(A)3, (A)(4), and (A)(7), discussion and consultation with designated representatives of the City including receiving legal advice from its attorneys in order to consider its position and instruct city representatives regarding contracts that are the subject of negotiations, namely, a possible agreement with the Arizona Department of Transportation for possible turn-back of portions of Hwy 89A, which agreement may also contemplate the acquisition of real property comprising portions of this roadway. Any contract that may ultimately result from such negotiations will subsequently be discussed, reviewed and either approved or disapproved by the City Council in an open meeting.
- c. Return to open session. Discussion/possible action on executive session items.
